

## **Memorandum of Understanding**

The University of Guilan, I.R. Iran
and
Batumi Arts State University



### **PREAMBLE**

For the purpose of teaching and research integration in high education sphere, collaborating joint educational programs, students and academic members participation in exchange and other creative programs sides are agreed on collaboration.

Collaboration will support:

- Academic members' participation in joint programs necessary for creative and academic education.
- Conducting consultations, master classes and other studying creative activities by the specialists of practical and theoretical direction.
- Rising professional level, integrating in international space, growing significantly the qualities of master works.
- Conducting joint research projects and special exhibitions in the field of art and social sciences.

#### Article 1

- 1.1 The sides are following the agreed policy in order to provide both universities with specialists necessary for academic education:
  - To conduct master classes, workshops and seminars;
  - To give consultations in order to launch educational programs;
  - To prepare joint master programs.
- 1.2 The sides will give consultations to each other in order to involve the students of both universities in students' exchange programs and intern professors and teachers.
- 1.3 The sides will take part in students' creative projects: festivals, competitions, concert performances, exhibitions, etc.
- 1.4 The sides will work out measures in order to carry out students and young specialists' summer school programs.
- 1.5 The sides will take part in co-supervision of the Master students' theses of both universities.
- 1.6 They will take part in joint international scholarship projects.
